PROPOSALS FOR PRE-QUALIFICATION OF ENGINEERING AND PROJECT MANAGEMENT CONSULTANCY FIRMS FOR OIL & GAS INFRASTRUCTURE AND IMPORT PROJECTS IN PAKISTAN

Inter State Gas Systems (Pvt.) Limited (ISGS) is a company incorporated in 1996 under the Companies Act, 2017 with its registered office at 8th Floor, Petroleum House, Ataturk Avenue, G-5/2, Islamabad. ISGS is wholly owned subsidiary of Government Holdings (Pvt.) Ltd. and working under the auspices of Ministry of Energy (Petroleum Division), Government of Pakistan.

2. ISGS invites applications for pre-qualification of consultancy firms having experience in Engineering and Project Management Consultancy (EPMC) services. The applicants can be firms/Joint Ventures/Consortiums, both local & foreign. The pre-qualified firms shall be required to provide engineering and project related consultancy services as specified in the Annex-I of the Pre-Qualification Documents. The applicants are required to comply with the local laws of Islamic Republic of Pakistan in order to provide services in Pakistan. Applicants who are not registered with Pakistan Engineering Council (PEC), Securities & Exchange Commission of Pakistan (SECP) or tax authorities (Federal Board of Revenue), etc. will have to comply with the requirements before execution of the contract(s). Such applicants shall submit, at the time of pre-qualification application submission, a copy of the application submitted with the respective authorities along with the undertaking that they will comply with the applicable local laws for the provision of services.

Pre-Qualification Documents, containing all information required for pre-qualification including instruction for preparation and submission of pre-qualification applications, evaluation criteria etc. are available for the interested applicants to be downloaded from the website of ISGS (www.isgs.com.pk) till 11th September, 2017. Prospective applicants may request a clarification on any aspect of these Pre-Qualification Documents till 12th September 2017.

4. Pre-qualification applications, prepared in accordance with the instructions provided in the Pre-Qualification Documents, must reach at following address on or before 25th September, 2017 at 1100 Hrs. Pre-qualification applications will be opened on the same day at 1130 Hrs. In case the day of pre-qualification applications submission and opening falls on a public holiday, next working day shall be considered as the deadline for the same.
